260302	I have been contacted by West Suffolk Community Services through my principal at the osteopathic clinic, to redeploy my services through the 'Allied Health Professionals Redeployment Request'. I have offered my services and am assuming that it is acceptable to do so, even though chiropractors are not on the AHP list?	Supporting the NHS	We are seeing a lot of activity in the Member Facebook group regarding the openings for chiropractors to make themselves available for support services within the NHS response to the crisis. We are currently working to compile the opportunities and mechanisms for access we become aware of. In many cases, this will involve individual chiropractors contacting local NHS resources to understand the specific needs and routes to access. 			can click through to a survey. One question asks if you are HCPC registered and if you answer 'yes' and carry on, you can use 'other' to indicate your profession. The GCC is in touch with NHS England colleagues responsible for dealing with the interest generated by this site to ensure they are aware that Chiropractors are registered healthcare professionals – in the same way as registrants of the Health and Care Professions Council. It is hoped this will facilitate your application being considered positively.
